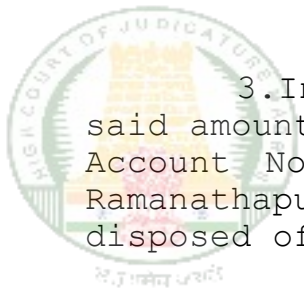
Prayer in CRP. (MD) No.693 of 2021:-

ORDER:- This Petition coming on for hearing on this day and upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr.J.Gunaseelan Muthiah, Advocate for the Petitioner and of Mr.A.John Vincent, Advocate for the Respondent, this court made the following order;

This Court by order dated 25.02.2022 in CRP(MD)No.693 of 2021 directed the petitioner to pay a sum of Rs.1,00,000/- (Rupees One lakh only) to the respondent on or before 21.03.2022. Seeking modification, the present Civil Miscellaneous Petition is filed.

2.When the matter is taken up for hearing, the learned counsel for the petitioner submitted that he is ready to comply with the condition given by this Court. However, he wants this Court to permit him to deposit the said amount to the respondent's account.



3. In view of above, the petitioner is directed to deposit the said amount to the respondent's account [State Bank of India Savings Account No.32730988490, IFSC Code:SBIN0000756, Paramakudi Branch, Ramanathapuram District] and the Civil Miscellaneous Petition is disposed of.
