PRAYER: Writ Petition filed under Article 226 of the Constitution of India for issuance of Writ of Mandamus, directing the respondents to conduct survey and fix four boundaries of the petitioner's house and land in Kumbakonam Town Survey No.1420 situated in Door No.33, Mela Theru, Jeganathapillaiyar Temple Street, Kumbakonam Town, Thanjavur District based on her representation dated 16.02.2022.

O R D E R

This writ petition has been filed for a Mandamus seeking for a direction to the respondents to conduct survey and fix four boundaries of the petitioner's house and land in Kumbakonam Town Survey No.1420 situated in Door No.33, Mela Theru, Jeganathapillaiyar Temple Street, Kumbakonam Town, Thanjavur District based on her representation dated 16.02.2022, within a time frame to be fixed by this Court.

2.The petitioner has submitted a representation to the respondents on 16.02.2022, seeking for survey and demarcation of boundaries in respect of the aforementioned property which she claims that it belongs to her absolutely. Since the said representation has not been considered till date, this writ petition has been filed.



3. Heard Mr.S.Sankar, learned Counsel for the writ petitioner and Mr.D.Sasikumar, learned Additional Government Pleader who accepts notice on behalf of the respondents.

4. The petitioner has produced documents in support of her case that she is the owner of the aforementioned property. She has sought for a survey and fixation of boundaries by the appointment of a Surveyor and the petitioner has given a representation on 16.02.2022 for the said purpose.

5. No prejudice would be caused to the respondents if the representation of the petitioner dated 16.02.2022 is considered on merits and in accordance with law after hearing the petitioner as well as the rival claimants if any.

6. Accordingly, this Court directs the second respondent to survey and fix the boundaries in the petitioner's house and land in Kumbakonam Town Survey No.1420 situated in Door No.33, Mela Theru, Jeganathapillaiyar Temple Street, Kumbakonam Town, Thanjavur District, after giving notice to the petitioner and rival claimants if any within a period of twelve [12] weeks from the date of receipt of a copy of this order.

7. With the above direction, this Writ Petition stands disposed of. There shall be no order as to costs.
