PRAYER: Writ Miscellaneous Petition filed under Article 226 of the Constitution of India, to grant leave to the petitioners to file the review application to set aside the order passed in W.P.(MD) No.6638 of 2021 dated 17.02.2022.

Prayer in WP(MD). 6638 OF 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing these respondents 2 and 3, to handover the charges and possession of the administration of the St.Georges Church situated in Main Guard Square, which is under the administrative control of the respondents 2 and 3, as per the order of this Honble High Court dated 03-10-2019, passed in W.P.No.21175 of 2019, within a time frame to this petitioner as the secretary and his executive members.
