PRAYER: Writ Petition filed under Article 226 of the Constitution of India for issuance of Writ of Mandamus, directing the respondent Nos.2 and 3 to issue application cum tender schedule to the petitioner and permit him to participate in the Tender /Auction in respective of various works falling under the jurisdiction of the 2nd Respondent in the year 2022-2025 by following the Fair and Reasonable Procedure in Terms of Tamil Nadu Transparency in Tenders Act-1998, Consequently direct the 2nd Respondent to collect the Tender / Auction Bids (Demand Drafts or Cheques) one day before the date of Tender / Auction schedule i.e before 24.03.2022.

Liberty is granted to the petitioner to challenge the said notice dated 18.03.2022 in the manner known to him under law. There shall be no order as to costs.
