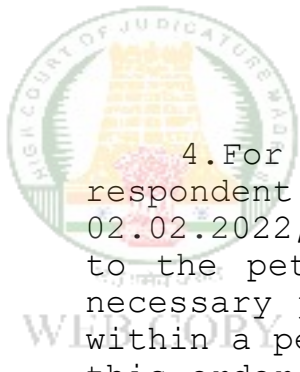

ORDER

4.For the foregoing reasons, this Court directs the first respondent to dispose of the petitioner's revision petition, dated 02.02.2022, by passing final orders, after affording a fair hearing to the petitioner and the fourth respondent as well as any other necessary parties, whom the first respondent deems fit to enquire, within a period of four months from the date of receipt of a copy of this order.

5.With the aforesaid directions, this writ petition is disposed of. No costs.
