3.Considering facts and circumstances of the case and also considering the nature of the offence alleged, this Court is inclined to modify the condition imposed by the learned Principal Sessions Judge, Madurai, and the petitioner is directed to appear before the Thideer Nagar Police Station daily at 10.30 am until further orders and the other conditions imposed by the learned Principal Sessions Judge, Madurai, shall remain unaltered.

4.With the above direction, the Criminal Original Petition is disposed of.
