ORDER

3. The learned Government Advocate (Criminal Side) would submit that the case is pending committal.

Under such circumstances, there shall be a direction to the learned Judicial Magistrate No.VI, Madurai to commit the case in P.R.C.No.268 of 2020 to the Court of Sessions within a period of two weeks from the date of receipt of a copy of this order. On receipt of the same, the Sessions Court is directed to complete the trial proceedings within a period of six months therefrom and report compliance to this Court after completion of the proceedings. Further, the petitioner shall appear before the trial Court on all hearing dates without fail and co-operate for trial.



5. With the above direction, the Criminal Original Petition is disposed of.
