PRAYER: Contempt Petition filed under Section 11 of Contempt of Courts Act, 1971, to punish the respondent for the willful and deliberate disobedience to the orders of this Court made in W.P.(MD) No.142 of 2020, dated 06.01.2020.

Prayer in WP(MD). 142/ 2020 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court Directing the respondent to pay interest at the rate of 18 percent per annum, for the period of delay from 01.04.19 to 21.09.19, in paying the amounts paid towards the terminal and pension benefits of the petitioner namely EPF Employees Contribution, Gratuity and Encashment of Earned Leaves and Commuted Value of Pension within a time frame as may be fixed by this Honourable Court and without affecting his right to claim balance amounts towards those benefits and thus render justice
