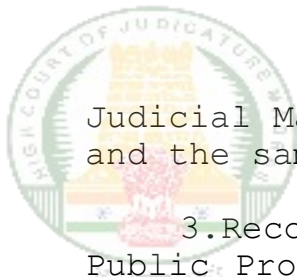
Prayer in CRL OP(MD)NO.16683 OF 2019:-
