ORDER

This Criminal Original Petition has been filed to transfer the investigation of the case in Crime No.56 of 2021 from the file of the third respondent Police to CBCID/4th respondent for further investigation and to file a final report before the concerned Court.

2.The learned counsel appearing for the petitioner submitted that the petitioner gave a complaint before the third respondent. Since no action has been taken, the petitioner has filed a private complaint under Section 156(3) of Cr.P.C. before the Judicial Magistrate Court, Uthamapalayam, in CrI.M.P.No.6962 of 2021 and the same was forwarded to the third respondent to register a case and to file a final report. Till now, the third respondent police has not taken any action to file a final report. Hence, the present petition has been filed.
