The petitioner seeks production of the detainee, namely, Balathandayuthapani, aged 50 years, who is his brother.

2. Heard the learned counsel appearing on either side and perused the materials placed before this Court.

3. According to the petitioner, the third respondent, the estranged wife of the detainee is illegally detaining him.
