This application has been filed for extension of interim stay granted in C.M.P.(MD).No.7948 of 2021 in S.A.(MD).No.18 of 2020, dated 02.02.2022.

2. According to the learned counsel for the petitioner, originally interim stay was extended on 02.03.2022, but the Court record shows that it was not extended. Therefore, the petitioner has filed the present application for extension of interim stay.

3. Considering the fact that this Court has granted interim stay on 01.11.2021 and the same was extended periodically till 02.02.2022, this Court is of the view that the same would be extended.
