ORDER

It is seen from the records that this Court vide order dated 31.10.2022 directed learned District Munsif, Nilakottai to complete the trial and dispose of the suit in O.S.Nos.31 of 2016 and 77 of 2018 within a period of three months from the date of receipt of a copy of the said order and both the parties were directed to extend their co-operation for the disposal of the suits within the time
