affording a fair hearing to the petitioner and other necessary parties whom the first respondent deems fit to enquire within a period of twelve [12] weeks from the date of receipt of a copy of this order.

5. With the aforesaid direction, this Writ Petition stands disposed of. There shall be no order as to costs.
