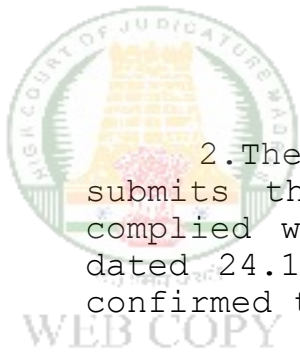
**Prayer in WP(MD). 738/ 2020 :**
