PRAYER :- Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Mandamus, directing the Respondents to grant permission and necessary protection to conduct the Adal Padal Programme on 12.04.2022 at 06.00 pm to 11.00 pm in connection with Thiru Vizha of Arulmigu Sri Pathrakaliamman, Sri Mariamman Thirukovil, Kamatchipuram, Uthamapalayam Taluk, Theni District.

O R D E R

This Writ Petition has been filed to issue a Writ of Mandamus, directing the Respondents to grant permission and necessary protection to conduct the Adal Padal Programme on 12.04.2022 at 06.00 pm to 11.00 pm in connection with Thiru Vizha of Arulmigu Sri Pathrakaliamman, Sri Mariamman Thirukovil, Kamatchipuram, Uthamapalayam Taluk, Theni District.

2.Heard the learned counsel for the petitioner as well as the learned Additional Public Prosecutor appearing on behalf of the respondents.

3.In an identical matter, a Division Bench of this Court in an order passed in **W.P. (MD) No.8975 of 2017 dated 10.05.2017 [M.Sakthi**



Vs. State rep. by the Inspector of Police, Odapatti Police Station, Odapatti, Theni District], had granted permission to the petitioner therein to conduct cultural programme on certain conditions. The said conditions read as follows:

'a)The event shall be conducted in an organised and peaceful manner without causing law and order problem.

b)There shall not be any obscene or vulgar scenes during the dance performance by any one of the participants or others.

c)The cultural Program shall be restricted between 6.00 p.m. and 11.00 p.m.

d)If there is any violation of the above said conditions, the respondents or the duly authorised officer is entitled to take necessary action as per law and stop such performance.

e)In case if there is any discrepancy with regard to the date on which the program is to be conducted, it would be open to the respondent police to extend protection on some other day after giving due notice to the petitioner.'

4.This Court is of the view that similar conditions may also be imposed in the present writ petition. The petitioner is directed to pay a sum of Rs.5,000/- (Rupees Five thousand only) as costs to the credit of Government of Tamil Nadu, CMPRF in IOB, Secretariat Branch, Chennai-9 (Account No.11720 10000 00070, IFSC Code: IOBA0001172) on or before 11.04.2022 and on receipt of the same, the second respondent is directed to strictly adhere to the Standard Operating Procedure adopted by the Government of Tamil Nadu and grant permission to the writ petitioner to conduct the cultural program **on 12.04.2022 between 6.00 pm., to 11.00 p.m.,** at **Arulmigu Sri Pathrakaliamman, Sri Mariamman Thirukovil, Kamatchipuram, Uthamapalayam Taluk, Theni District,** subject to the aforesaid conditions.

5.With the above directions, this Writ Petition disposed of.

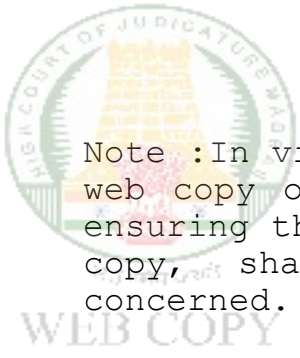
