2.The learned Additional Public Prosecutor submitted that the petitioner is an accused in Crime No.482 of 2011, registered for the offence punishable under Section 302 IPC. Therefore, the permission sought for by the petitioner cannot be granted, to conduct cultural programme. However, the representation of the petitioner dated 12.03.2022 is pending on the file of the second respondent.

3.In view of the above, the second respondent is hereby directed to dispose the representation of the petitioner dated 21.03.2022, on or before **09.04.2022**.
