Prayer in Crl.MP No.5460 of 2022:-

This Criminal Miscellaneous Petition filed under section 482 of Cr.P.C, to relax the condition imposed by this court in Crl A (MD) No. 107 of 2022 vide order dt. 03.03.2022 in respect of the case in Crime No. 40 of 2022 pending on the file of the 2nd respondent police.

Prayer in Crl .A No.107/2022:

This Criminal Appeal filed under section 14-A(II) of Scheduled castes and Schedule Tribes(prevention of Atrocities) Act 1989 (Amendment Act at 2016), to set aside the order passed in Crl.MP(MD) 92 of 2022 dated 17/02/2022, on the file of the II Additional Sessions Court, Tirunelveli and allow the Criminal Appeal and enlarge the Appellant on Bail concerned in Crime No.40 of 2022 on the file of the 2nd respondent police.

In the light of the above submission, the condition imposed on the petitioner in Crl.A(MD).No.107 of 2022 dated 03.03.2022 is modified to the effect that the petitioner shall appear before the respondent police once in a month i.e., on the first working day of every English calendar month at 10.30 a.m., until further orders.
