2.The learned counsel for the petitioners would submit that the petitioners 1, 2 and 4 have complied with the condition for a period of 22 days, without fail. Hence, the petitioners 1, 2 and 4 may be permitted to report before the Judicial Magistrate No.IV, Tirunelveli for the remaining period.



3.The above submission is admitted by the learned Government Advocate (Criminal Side) appearing for the respondent police.

4.Considering the above, the condition is fully relaxed.

5.The Criminal Miscellaneous Petition is ordered accordingly.
