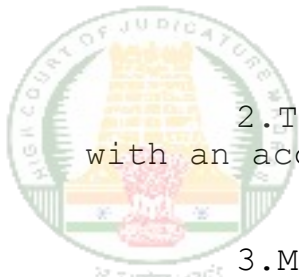
ORDER

The petitioner seeks one month ordinary leave or one week emergent leave for her husband, namely, Doss @ Vattakan @ Perumal @ Pethaperumal, who is life convict undergoing imprisonment at Trichy Central Prison.



2.The reason for seeking leave is that the prisoner has met with an accident in the jail and he needs emergent treatment.

3.Mr.S.Ravi, learned Additional Public Prosecutor appearing for the respondents would submit that the representation of the petitioner dated 30.03.2022 is under active consideration and the department has sought for an opinion of the Probationary Officer and local police. They would pass suitable order, immediately on receipt of the opinion.

4.Considering the fact that the leave is sought for on medical grounds, this Writ Petition is disposed of with a direction to the authorities to consider the representation of the petitioner at the earliest time at any rate not later than 29.04.2022. No costs.
