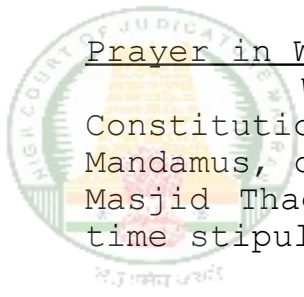

Prayer in WP(MD). 11120/ 2020 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a writ of Mandamus, directing the 1st Respondent to conduct election at the Al Masjid Thaqwa Sunnath Wal Jamath (Hanafi) Mosque Waqf, within the time stipulated by this Honourable Court.

2. This Writ Miscellaneous Petition is allowed. The Advocate Commissioner is directed to conclude the entire election process within a period of one month from the date of receipt of a copy of this order. The remuneration of the Advocate Commissioner is fixed at Rs.10,000/- (Rupees Ten Thousand Only).

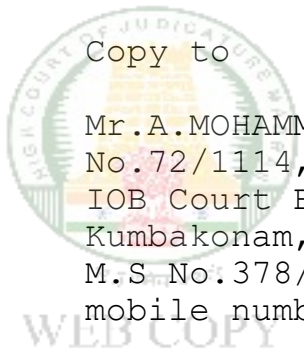
