Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus, directing the 3rd respondent to hand over the panchayat records to the petitioner i.e. K.Dharmathupatti Grade I village Panchayat, Reddiar Chathiram Union, Dindigul District by considering the petitioner representation dated 27.01.2022.
