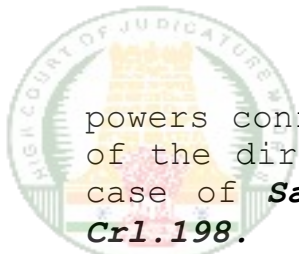

powers conferred under Article 226 of Constitution of India, in view of the directions issued by the Division Bench of this Court in the case of **Saleema Vs. State of Tamil Nadu** reported in **2021 (1) MWN Cr1.198**. Accordingly, this Writ Petition stands dismissed. No costs.
