2. Accordingly, the second respondent filed a petition along with condone delay to 1590 days filing the petition for confirmation of attachment as contemplated under Section 4(3) of TNPID Act before the Special Court for TNPID Act, Madurai. It was allowed in I.A.No.62 of 2021 dated 20.12.2021. The same has been challenged by one of the accused persons before this Court in C.R.P.(MD).No.169 of 2022 and this Court stayed all further proceedings.
