In view of the same, the Tahsildhar, Thirupathur, Sivagangai District is directed to pass orders in the peace committee meeting to be held for conducting the Chitra Pournami festival on 16.04.2022 in Arulmigu Jeyamkondal @ Poongunkra Nayaki Amman Thirukovil, Magibalanpatti, Thiruppathur Taluk, Sivagangai District forthwith.

4. With the above direction, the Writ Petition stands disposed of. There shall be no order as to costs.
