**PRAYER IN CRL A(MD) No.441 of 2021:**

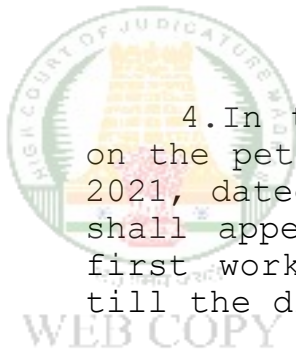
