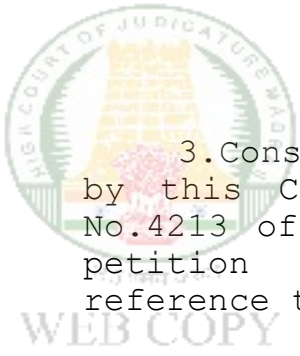
Prayer in Crl.O.P.(MD) No.4213 of 2021:-
