3.Learned Counsel for the petitioner seeks permission of this Court to challenge the same in the manner known to the petitioner under law.

4.After recording the submission made by the learned Counsel for the petitioner, this Writ Petition is disposed of by granting liberty to the petitioner to challenge the order dated 26.06.2019 passed by the fourth respondent rejecting the petitioner's application seeking for issuance of patta, in the manner known to the petitioner under law. There shall be no order as to costs. Consequently, the connected miscellaneous petition is closed.
