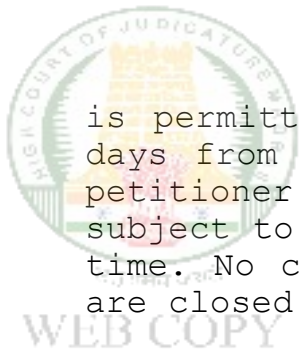

Consequently, the connected miscellaneous petitions are closed.
