This writ petition has been filed seeking for a Mandamus to direct the respondents to issue patta in favour of the petitioner based on her representation dated 16.03.2022.

3. It is brought to the notice of this Court by the learned Additional Government Pleader appearing for the respondent that the petitioner's representation dated 16.03.2022 seeking for issuance of patta has already been considered and rejected on 13.04.2022.

4. Learned Counsel for the petitioner seeks liberty of this Court for the petitioner to challenge the same in the manner known to the petitioner under law. The said statement is recorded.

5. After recording the submissions made by the respective Counsels, this writ petition is disposed of by granting liberty to the petitioner to challenge the order dated 13.04.2022 by which the
