The relief sought for in the present writ petition is to quash the order dated 14.02.2020 passed by the 3<sup>rd</sup> respondent and consequently to direct the respondents to revise and refix the basic



pay of the petitioner to the post of Assistant (Clerk).

The learned Additional Government Pleader made a submission that during the pendency of the writ petition, the petitioner has joined at Kanchipuram District Central Cooperative Bank at Kanchipuram. Based on his appointment, the petitioner also given an application to relieve him from the 3<sup>rd</sup> respondent-society and pursuant to the application submitted by the petitioner, he was relieved from the post on 26.02.2021

3. In view of the fact that the petitioner has already been relieved and appointed in Kanchipuram District Central Cooperative Bank, Kanchipuram, this Court is of the opinion that the cause do not exist and therefore, no further adjudication is required in this writ petition.

4. Accordingly, this Writ Petition stands closed. No costs. Consequently, connected miscellaneous petition is also closed.
