Writ Petition is filed under Article 226 of the Constitution of India, praying this Court S-4 To issue a Writ of Certiorarified Mandamus calling for the records relating to the impugned order terminating the contract under letter No.3021/Discp/292/ECHS dated 26.08.21 on the file of the Respondent and quash the same and further directing the respondent to permit the petitioner to attend the interview for the post of Safaiwallah under Ex-serviceman Contributory Health Scheme Hospital in pursuant to the employment notice dated 14.07.21 and to pass such further or other orders as this Honble Court may deem fit proper in the said circumstances of this case and thus render justice.
