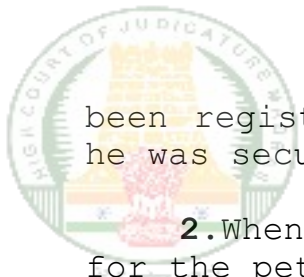
**PRAYER IN CRL A(MD)No. 363 of 2022:**
