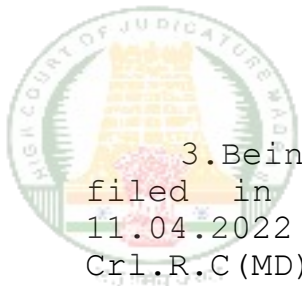
Prayer in CRL RC(MD) . 186 of 2022 :
