PRAYER: Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, directing the Respondents herein to survey measure and fix the four boundaries in respect of the Petitioners property comprised in Survey No.141/8 of Viswantham Village, Sivakasi Taluk, Virudhunagar District by following the order passed by this Court in W.P(MD).No.20609 of 2021, dated 07.04.2022, by considering the Petitioner's application, dated 19.04.2022, within the time stipulated by this Court.

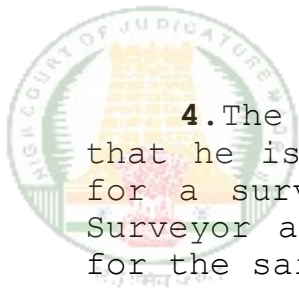

ORDER

This writ petition has been filed for a Mandamus seeking for a direction to the respondents to survey the property comprised in Survey No.141/8 of Viswantham Village, Sivakasi Taluk, Virudhunagar District, on the basis of petitioner's application dated 19.04.2022 within a time frame to be fixed by this Court.

2.The petitioner has submitted an application to the respondents on 19.04.2022 seeking for survey and demarcation of boundaries in respect of the aforementioned property, which he claims that it belongs to him absolutely. Since the said application has not been considered till date, this writ petition has been filed.

3.Heard Mr.P.Mahendran, learned Counsel for the writ petitioner and Mr.B.Saravanan, learned Additional Government Pleader, who accepts notice on behalf of the respondents.



4.The petitioner has produced documents in support of his case that he is the owner of the aforementioned property. He has sought for a survey and fixation of boundaries by the appointment of a Surveyor and the petitioner has given an application on 19.04.2022 for the said purpose.

5.No prejudice would be caused to the respondents, if the survey and demarcation of the boundaries is done in the presence of the petitioner and any other necessary party, whom the respondents deem fit to put on notice at the time of survey.

6.Accordingly, this Court directs the respondents to survey and fix the boundaries in the petitioner's property comprised in Survey No.141/8 of Viswantham Village, Sivakasi Taluk, Virudhunagar District, after giving notice to the petitioner and any other necessary party, whom the respondents deem fit to put on notice at the time of survey, within a period of twelve [12] weeks from the date of receipt of a copy of this order.

7.With the above direction, this Writ Petition stands disposed of. There shall be no order as to costs.
