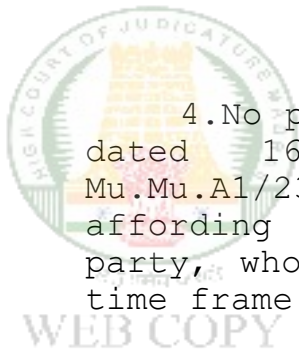

ORDER

2.Heard Ms.J.Annie Infanta, learned counsel appearing for the petitioner and Mr.D.Sasikumar, learned Additional Government Pleader, who accepts notice on behalf of the respondents.

3.Under the order, dated 16.04.2021, passed by the first respondent, the error sought to be rectified by the petitioner has been accepted by the first respondent. Since the order has not been implemented till date, the petitioner has filed this writ petition.



4.No prejudice will be caused to the respondents, if the order, dated 16.04.2021, passed by the first respondent in Mu.Mu.A1/2342/2021, is implemented by the second respondent after affording a fair hearing to the petitioner and any other necessary party, whom the second respondent deems fit to enquire, within a time frame to be fixed by this Court.

5.For the foregoing reasons, this Court directs the second respondent to implement the order, dated 16.04.2021, passed by the first respondent in Mu.Mu.A1/2342/2021, within a period of eight weeks from the date of receipt of a copy of this order, after affording a fair hearing to the petitioner and any other necessary party, whom the second respondent deems fit to enquire, including granting them the right of personal hearing.

6.With the aforesaid directions, this writ petition is disposed of. No costs.
