There shall be an order of interim stay on condition that the petitioner deposits a sum of Rs.1,50,000/- [Rupees One Lakh and Fifty Thousand only] to the credit of M.C.No.16 of 2012 on the file of the Judicial Magistrate Court, Sivakasi, on or before 13.08.2019. It is made clear that if the petitioner fails to comply with the conditional order, the interim stay granted shall stand automatically vacated without any further reference to this Court.

2. Post the matter on 16.08.2019.

3. Issue notice to the respondent returnable by then. Private notice is also permitted.
