PRAYER :- Writ Petition is filed under Article 226 of the Constitution of India, praying to issue a Writ of Mandamus, directing the Respondents herein to give permission and Police protection for conducting *Mulaippari Eduppu* Function and *Valli Thirumana Nadagam* is going to be conducted on 03.05.2022 and 04.05.2022 at 6.00 P.M. and 11.00 P.M. in connection with Chithirai Thiruvizha Celebration of Arulmigu Muthumariamman Temple situated at Samuthirapatti Village, Valaramanickam Post, Thirumayam Taluk, Pudukkottai District based upon the Petitioners Representation dated 22.04.2022.

O R D E R

This Writ Petition is filed to issue a Writ of Mandamus directing the Respondents herein to give permission and Police protection for conducting *Mulaippari Eduppu* Function and *Valli Thirumana Nadagam* is going to be conducted on 03.05.2022 and 04.05.2022 at 6.00 P.M. and 11.00 P.M. in connection with Chithirai Thiruvizha Celebration of Arulmigu Muthumariamman Temple situated at Samuthirapatti Village, Valaramanickam Post, Thirumayam Taluk, Pudukkottai District based upon the Petitioners Representation dated 22.04.2022.



2. Heard the learned counsel for the petitioner as well as the learned Additional Public Prosecutor appearing on behalf of the respondents.

3. In an identical matter, a Division Bench of this Court in an order passed in ***W.P. (MD) No.8975 of 2017 dated 10.05.2017 [M.Sakthi Vs. State rep. by the Inspector of Police, Odapatti Police Station, Odapatti, Theni District]***, had granted permission to the petitioner therein to conduct cultural programme on certain conditions. The said conditions read as follows:

"a) The event shall be conducted in an organised and peaceful manner without causing law and order problem.

b) There shall not be any obscene or vulgar scenes during the dance performance by any one of the participants or others.

c) The Program shall be restricted between 6.00 pm., and 11.00 p.m.

d) If there is any violation of the above said conditions, the respondents or the duly authorised officer is entitled to take necessary action as per law and stop such performance.

e) In case if there is any discrepancy with regard to the date on which the program is to be conducted, it would be open to the respondent police to extend protection on some other day after giving due notice to the petitioner".

4. This Court is of the view that similar conditions may also be imposed in the present writ petition. Consequently, the Writ Petition Stands allowed. The petitioner is directed to pay a sum of Rs.10,000/- (Rupees Ten thousand only) as costs to the credit of Government of Tamil Nadu, CMPRF in IOB, Secretariat Branch, Chennai-9 (Account No.11720 10000 00070, IFSC Code: IOBA0001172) on or before 03.05.2022 and on receipt of the same, the second respondent is directed to strictly adhere to the Standard Operating Procedure adopted by the Government of Tamil Nadu and grant permission to the writ petitioner to conduct the programme on 03.05.2022 to 04.05.2022 between 6.00 p.m., and 11.00 p.m., at Arulmigu Muthumariamman Temple situated at Samuthirapatti Village, Valaramanickam Post, Thirumayam Taluk, Pudukkottai District subject to the aforesaid conditions. There shall be no order as to costs.

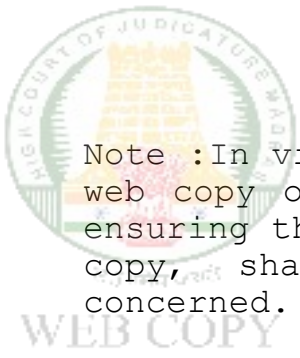
