Prayer : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, to direct all the respondents to issue assignment order to the petitioner in respect of Panjami land comprised in Survey No.150 admeasuring an extent of 2 acres and 50 cents situated in Keeranur Village, Pooniuthi Post, Melur Taluk, Madurai District based on the



petitioner's representation dated 22.04.2022 within a stipulated time that may be fixed by this Court.

ORDER

This Writ Petition has been filed for a Mandamus seeking for a direction to the respondents to issue assignment order to the petitioner in respect of Panjami land comprised in Survey No.150 admeasuring an extent of 2 acres and 50 cents situated at Keeranur Village, Poonjuthi Post, Melur Taluk, Madurai District based on the petitioner's representation dated 22.04.2022, within a time frame to be fixed by this Court.

2. The case of the petitioner is that she has been doing agricultural activities in the aforementioned property for more than 20 years. According to her, the aforementioned lands are panjami lands. She has sought for assignment order for the said lands in her name and has given a representation on 22.04.2022, to the respondents. Since the said representation has not been considered till date, the petitioner has filed this Writ Petition.

3. Heard Mr.K.A.S.Prabhu, learned counsel for the petitioner and Mr.M.Lingadurai, learned Special Government Pleader, who accepts notice on behalf of the respondents.

4. No prejudice will be caused to the respondents, if the representation of the petitioner is considered on merits and in accordance with law, after affording a fair hearing to the petitioner. The petitioner claims that she is doing agricultural operations in the aforementioned panjami lands for more than 20 years. It is for her to establish her case before the respondents, when her representation is considered on merits and in accordance with law, pursuant to the directions given by this Court today.

5. For the foregoing reasons, this Court directs the sixth respondent to consider the petitioner's representation, dated 22.04.2022, requesting the respondents to issue an assignment order in her favour in respect of the panjami land comprised in Survey No.150 admeasuring an extent of 2 acres and 50 cents situated at Keeranur Village, Poonjuthi Post, Melur Taluk, Madurai District and pass final orders on merits and in accordance with law, after affording a fair hearing to the petitioner and any other necessary parties, whom the sixth respondent deems fit to enquire, within a period of twelve (12) weeks from the date of receipt of a copy of this order.



6. With the above direction, this Writ Petition stands disposed of. There shall be no order as to costs.
