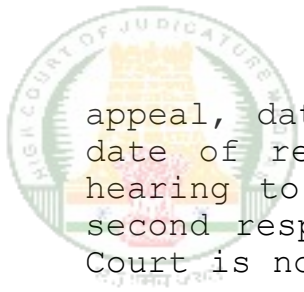
ORDER

appeal, dated 27.09.2021, within a period of three months from the date of receipt of a copy of this order, after affording a fair hearing to the petitioner and any other necessary party, whom the second respondent deems fit to enquire. It is made clear that this Court is not expressing any opinion on the merits of the matter.

5. With the aforesaid directions, this writ petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.
