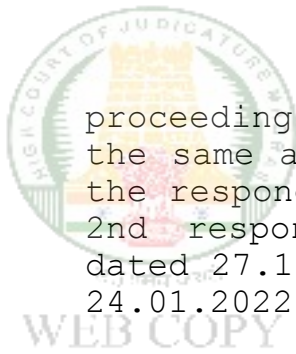

The learned District Munsif, Melur is requested to adhere to the extended time limit.

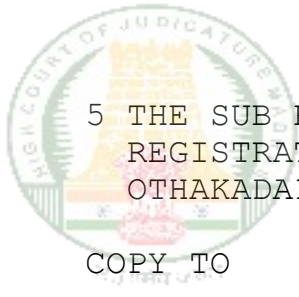
