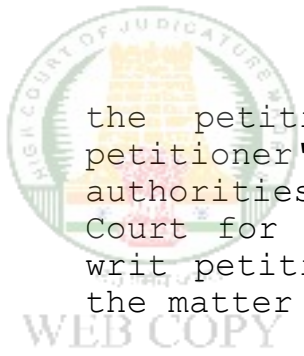

Heard the learned counsel appearing for the petitioner and the learned Additional Government Pleader appearing for the respondents.

2. The petitioner has given a representation to the second respondent dated 27.08.2021. I went through the contents of the representation. It is clear that there is a civil dispute between one Pandian on the one hand and Maruthu on the other hand. Whether



the petition mentioned pathway is a common pathway or the petitioner's exclusive pathway, cannot be decided by the revenue authorities. The petitioner has to approach the jurisdictional Court for appropriate relief. No direction as sought for in this writ petition can be granted. I have not gone into the merits of the matter . All the contentions of the petitioner are left open.

3. The writ petition stands dismissed. No costs.
