PRAYER: Writ Petition filed under Article 226 of the Constitution of India for issuance of Writ of Mandamus, to directing the respondents to survey and fix boundaries of the petitioner's lands bearing Survey Nos.99/10, 11, 12, 222/15, 220/7, 8, 221/10, 13, 14, 224/10, 9, 226/1, 11, 12, 14, 2, 8, 9, 238/3, 4, 1A, 1B, 5A, 6A, 7B, 8B, 161/3, 167/3, 231/10, 12, 233/4, 237/11, 7, 8 and its Patta Nos.276 and 1081, situated at Sorankulam (Avarankulam), Pillayarkulam Revenue Village, Thiruchuli Taluk, Virudhunagar District.

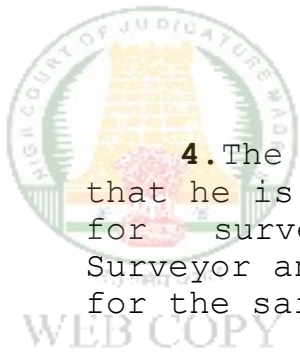

ORDER

This Writ Petition has been filed for a Mandamus seeking for a direction to the respondents to conduct survey of the petitioner's properties bearing Survey Nos.99/10, 11, 12, 222/15, 220/7, 8, 221/10, 13, 14, 224/10, 9, 226/1, 11, 12, 14, 2, 8, 9, 238/3, 4, 1A, 1B, 5A, 6A, 7B, 8B, 161/3, 167/3, 231/10, 12, 233/4, 237/11, 7, 8 and its Patta Nos.276 and 1081, situated at Sorankulam (Avarankulam), Pillayarkulam Revenue Village, Thiruchuli Taluk, Virudhunagar District. within a time frame to be fixed by this Court.

2.The petitioner has submitted a representation to the respondents on 23.09.2019 seeking for survey and demarcation of boundaries in respect of the aforementioned property, which he claims that it belongs to him absolutely. Since the said representation has not been considered till date, this Writ Petition has been filed.

3.Heard Mr.G.Hariharan, learned Counsel for the petitioner and Mr.M.Lingadurai, learned Special Government Pleader, who accepts notice on behalf of the respondents.



4.The petitioner has produced documents in support of his case that he is the owner of the aforementioned properties. He has sought for survey and fixation of boundaries by the appointment of a Surveyor and the petitioner has given a representation on 23.09.2019 for the said purpose.

5.No prejudice would be caused to the respondents, if the survey and demarcation of the boundaries is done in the presence of the petitioner and any other necessary party, whom the first respondent deems fit to put on notice at the time of survey.

6.Accordingly, this Court directs the first respondent to survey and fix the boundaries with the assistance of the second respondent in the petitioner's property bearing Survey Nos.99/10, 11, 12, 222/15, 220/7, 8, 221/10, 13, 14, 224/10, 9, 226/1, 11, 12, 14, 2, 8, 9, 238/3, 4, 1A, 1B, 5A, 6A, 7B, 8B, 161/3, 167/3, 231/10, 12, 233/4, 237/11, 7, 8 and its Patta Nos.276 and 1081, situated at Sorankulam (Avarankulam), Pillayarkulam Revenue Village, Thiruchuli Taluk, Virudhunagar District, after giving notice to the petitioner and any other necessary party, whom the first respondent deems fit to put on notice at the time of survey, within a period of twelve [12] weeks from the date of receipt of a copy of this order.

7.With the above directions, this Writ Petition stands disposed of. There shall be no order as to costs.
