2.It is evident from the records that this Court in earlier order dated 04.04.2022 in Crl.OP(MD) No.6755 of 2022, directed the first petitioner to appear before the respondent Police daily at 10.30 am for a period of one month and thereafter, as and when required for interrogation. Aggrieved by the same, the petitioners have filed the present petition.



3.The learned Government Advocate (Criminal Side) appearing for the State would submit that the investigation is pending.

4.Considering the above, the first petitioner is directed to appear before the respondent police daily at 06.00 p.m, until further orders.

5.The petition is ordered accordingly.
