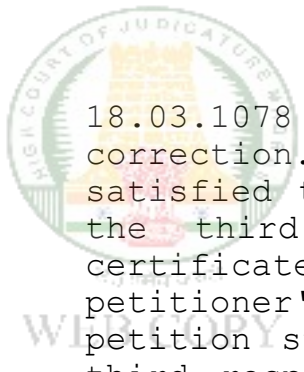

Therefore, the third respondent is directed to issue a revised birth certificate to the petitioner by mentioning the date of birth of the petitioner's daughter, Panchavarnam as 05.02.1978. The writ petition stands allowed. The certificate shall be issued by the third respondent within a period of four weeks from the date of receipt of a copy of this order. No costs.
