The petitioner has lodged complaint before the third respondent, however the third respondent did not register any case and as such the petitioner was constrained to file a petition under Section 156(3) of Cr.P.C before the learned Judicial Magistrate, Thirumangalam and the learned Magistrate by an order dated 28.01.2022 had directed the third respondent herein to investigate the matter and file a report, however the third respondent even till



today did not register any First Information Report and kept the matter in cold storage.

3. In view of the same, the third respondent is directed to register the First Information Report forthwith as against the accused persons as directed by the learned Judicial Magistrate, Thirumangalam and investigate the same.

4. With the above direction, the Criminal Original Petition stands disposed of.
