PRAYER: Writ Petition filed under Article 226 of the Constitution of India for issuance of Writ of Mandamus to direct the respondents herein to reimburse the medical claim of Rs.2,99,997-14 (Rupees two lakhs ninety nine thousand nine hundred ninety seven and paise fourteen only) together with interest at the rate of 7.5 percentage p.a. thereon to the petitioner covered by the medical records and medical bills within a reasonable time as may be fixed by this Court.
