Prayer: Writ petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, to direct the respondents to implement the Award No.15A/2021, dated 29.11.2021 and to pay compensation for petitioner's house property in Survey No.273/2M in Patta No.968 at Parambupatti Village, Perungudi Panchayat, Thiruparankundram Taluk, Madurai District, as per the provisions contemplated Under the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

O R D E R

Heard the learned counsel appearing for the petitioner and the learned Special Government Pleader appearing for the respondents.

2. The petitioner's land and buildings were acquired for Madurai Airport Expansion. The authorities paid compensation for the land. However, for the building portion, compensation was not paid. The competent authority passed an award on 29.11.2021 directing that a sum of Rs.3,97,879/- has to be paid as compensation for the buildings to the writ petitioner. Even though eight months have elapsed, till date, the award amount has not been paid. That led to the filing of the writ petition.

3. No exception can be taken to the writ prayer. The respondents are directed to pay the award amount together with

interest to the writ petitioner within a period of eight months from the date of receipt of a copy of this order.

4. The Writ Petition stands allowed. No costs.
