While doing so, the Survey Authorities will give notice not only to the petitioner but also to the impleaded respondent and the adjacent land owners. The entire exercise shall be completed within a period of three months from the date of receipt of a copy of this order.

4. Accordingly, the Writ Petition stands disposed of. No costs. Connected miscellaneous petition is closed.
