PRAYER IN CRL RC(MD) SR.No.16050 of 2022:

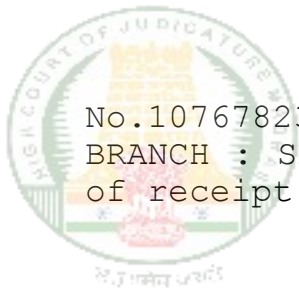
